

Code of Conduct for Trans-Tasman Patent and Trade Marks Attorneys 2018

The Australian and New Zealand Code of Conduct for Trans-Tasman Patent and Trade Marks Attorneys 2018 requires us to disclose certain information to you and to obtain consent to certain disclosures and uses of client information.

Ownership structure

AJ Park is an incorporated registered patent and trade marks attorney owned by IPH Limited, a public company that is the holding company for a number of intellectual property professional services businesses operating under different brands across the Asia-Pacific region.

AJ Park is bound by the Australian and New Zealand Code of Conduct for Trans-Tasman Patent and Trade Marks Attorneys 2018 (Code) and, for the purposes of the Code, is a member of an 'ownership group' within the meaning of the Code. The ownership group comprises Spruson & Ferguson Pty Limited, Spruson & Ferguson Lawyers Pty Ltd, Fisher Adams Kelly Pty Ltd, AJ Park IP Limited (and affiliated company AJ Park Law Limited), Practice Insight Pty Limited, Cullens Pty Ltd and Pizeys Patent and Trade Mark Attorneys Pty Ltd. Spruson & Ferguson and Pizeys also comprise patent and trade marks attorney entities outside Australia and New Zealand.
