New Zealand's new Patents Act 2013 Changes to annual renewal fees and the introduction of pre-grant maintenance fees

September 2014

The New Zealand Patents Act 2013 came into force on 13 September 2014.

When are maintenance/renewal fees due under the 2013 Act?

Under the 1953 Act, renewal fees were payable on granted New Zealand patents 4, 7, 10 and 13 years from the filing date. The new Act provides for annual maintenance fees payable 4 years from the filing date, then renewal fees annually after grant.

How much do the new fees cost?

The new maintenance/renewal fees are set out in the table below, with a comparison to the former renewal fees under the 1953 Act.

Late fees

Under the 2013 Act, late fees of NZ \$50 will apply to annual renewal/maintenance fees paid after the due date.

Transitional arrangements

The next renewal fee due is payable as per the 1953 schedule, but at the new 2013 Act rate. Renewal fees are then payable annually for the remaining life of the patent under the 2013 Act.

For example, if you were due to pay the 7th year fee of \$340 under the 1953 Act on 1 May 2016, you will now need to pay \$100 instead by the due date, and annual fees by 1 May for the next 12 years.

Can maintenance/renewal fees be paid in advance?

Under the 2013 Act, maintenance/renewal fees **may not be paid more than three months before the due date at the earliest**.
